To help my child at school, I know and understand that:

- I should encourage good infection control practices, such as thorough handwashing, at home and remind my child about social distancing rules but accept they are difficult to follow and that my child may not always do this successfully;
- I should ensure all members of the family adhere to social distancing inside and outside the home to avoid risk of infection to the children, their families, staff and the wider community;**
- I should support home learning wherever possible, if school has to be closed or partially closed because of COVID-19;
- I will not be allowed into the school without invitation or a pre-arranged appointment - make appointments via telephone or email and check school website or Facebook page for updates;
- I should read any messages/emails sent home and inform school immediately if any details or contact addresses change;
- I must adhere to the altered routines for arrival and departure and maintain the 2 metre social distancing rules;
- When dropping off and picking up, I must stick strictly to the school timings for my child;
- My child must not bring any items into school with them or take items home from school (excluding water bottle, snack, lunchbox and reading wallet);
- If my child, or anyone in my household, shows symptoms of COVID-19, I will not send them to school, I will get them tested and I will let the school know the result as soon as possible via telephone;
- If requested by school, I will collect my child immediately;
- I should be supportive of the changes to normal routine and measures put in place to ensure everyone is as safe as possible;
- I should be respectful to staff and follow their instructions;
- If my child is really unsafe in school, I will be contacted.
